The Hanleys:
Looking for Ways to Say "Yes"

At some point in time, everyone has been introduced to the different perspectives involved in the debate over whether the glass is "half-full" or "half-empty." I have always felt rather optimistic, given my "half-full" take on life, but that assessment was quickly altered when I met Tim Hanley. The day was October 17th and though it marked the three-year anniversary of the passing of Tim's younger brother Brian, the mood in the conference room at Deloitte & Touche's downtown Milwaukee office, where I met Tim, was overwhelmingly pleasant and amiable. Within the first few minutes of speaking with him, I found one thing abundantly clear: Tim and his family see their glass as uncontrollably overflowing.

Tim graduated from Marquette University's College of Business Administration in December of 1978 with a major in Accounting. Rather than graduating in May of 1978 with the rest of his class, Tim decided to take a semester off in the spring of 1977 to gain some experience as an intern with PricewaterhouseCoopers. Mrs. Tim Hanley, Monica, graduated from Marquette with a concentration in dental hygiene in May of 1981, three years after Tim. Both attended Catholic Memorial High School in Waukesha, Wisconsin, but due to the fact that Monica was three years younger, they did not officially begin dating until Tim graduated from Marquette. With a smile, Tim recalled their first date. The year was 1980, Monica was a junior at Marquette and Tim was two years out of college. They went to see Tim's younger brother Mark play in a varsity basketball game at Catholic Memorial. Four years later, they married.

When asked why they chose Marquette for their higher education, Tim and Monica agreed that it was partly the result of influence from family and friends. The main reasons, however, were the Jesuit tradition that

Marquette was so widely known for and what the Hanleys referred to as the full-circle experience that they knew would come from being a part of this unique and friendly community.

As Tim and Monica reminisced about their days at Marguette, both painted a picture of a time filled with accomplishment and fulfillment. Tim occupied his free hours with sports, sports, and more sports. Basketball was his first love and Tim recalls carving out three to four days a week at Marquette's Rec Center. When asked why he did not attempt to play basketball at the college level, Tim explained that while he had one or two opportunities at Division III schools, he wanted to concentrate on academics and his future in business. Monica was very involved in the student government sector of the dorms as an underclassman and served as a Residence Assistant during her junior and senior years. She took pleasure in organizing events and, in an attempt to give something back, became socially involved with those around her, especially the underclassmen. While at Marquette, Monica and Tim were both a part of Alpha Sigma Nu, one of the most prestigious Jesuit Honors Societies in the nation.

When asked what their favorite classes were and, maybe, some favorite professors, Tim responded that he was always extremely fond of our very own Drs. Don Giacomino and Jim Trebby, and that, in fact, he enjoyed all of his accounting courses. Tim noted his favorite class took place outside the College of Business: "Theory of Coaching Basketball," taught by Hank Raymonds. Monica could not recall a specific class that she enjoyed more than any other, but she did remember that she absolutely adored and admired the Jesuit professors who influenced and enhanced her Marquette experience.

Immediately upon graduating, Tim began working with Arthur Andersen's Milwaukee office in January of 1979. In his time with Arthur Andersen, he became head of the Audit practice and was appointed Managing Partner in 2001. Tim is currently the US Process and Industrial Products Industry Leader for Deloitte & Touche. He works with the audit, tax, consulting and financial advisory teams that serve many of the world's most significant manufacturing companies. Tim is also a member of the American Institute of Certified Public Accountants (AICPA) and the Wisconsin Institute of Certified Public Accountants (WICPA).

The entire Hanley family has some history at Marquette University. Tim is the oldest of five boys, four of whom graduated from Marquette: David graduated in 1982 from the College of Business with a degree in Marketing; Brian in 1987 from the College of Business with a degree in Accounting; and Steve in 1989 from the College of Business, also receiving his MBA from Marquette in 1994. Of Monica's three sisters and one brother, her older sister is a Marquette graduate. Tim's father graduated from Marquette in 1951 with a degree in Engineering.

Monica and Tim have been blessed with four children: Rob, 22 years old, is currently a senior in the Accounting program at Marquette; Laura, 20, is a sophomore in the College of Business at Notre Dame and looking forward to specializing in Finance or Accounting; Michael, 19, is a freshman at Marquette in the College of Business; and Colleen, 16, is a sophomore at Catholic Memorial High School.

Tim and Monica have both witnessed many changes in Marquette since their time as students. Tim commented on the many improvements made to the quality and appearance of Wisconsin Avenue, which runs through campus. Monica made reference to the unending amount of community service opportunities for the students at Marquette and the array of ways to get involved. In Monica's opinion, it is almost

impossible today not to help the community in some way during one's time at Marquette University. Tim commented also on the much improved Accounting program within the College of Business. He praised the department as he described the enhanced caliber of both students and professors within the department and the growing relationships with the Big Four accounting firms in Milwaukee.

Monica and Tim feel they have been blessed to reside in the same general community for most of their lives, making networks created and services performed rich and rewarding. Tim continues to add to an impressive resume of community participation that includes: board member and former president of Catholic Memorial High School Board; member of the Milwaukee Archbishop's School Advisory Board, participant in Partners Advancing Values in Education (PAVE) – a non-profit foundation that makes education opportunities available for Milwaukee families; former president of the Jesuit Partnership Council – a fundraising arm of the Jesuits; board member for Families International – a national non-profit organization; board member for Waukesha

Memorial Hospital Foundation. Tim also serves on the Board of Trustees for the Milwaukee County Council of Boy Scouts and the Dean's Advisory Council for Marquette's College of Business Administration.

Monica has focused a great deal of her time on providing service to their local parish and schools in the area and is also very involved as a volunteer at Waukesha Memorial Hospital. The Hanley's motto is "Look for ways to say 'Yes'!" and it is evident they both do just that.

The most moving story Tim shared with me was about an annual activity his younger brother Brian began back in 1990 with a group that has since been referred to as the "Dayton 10." In 1990, Marquette's basketball team joined a

Darren Jackson

Beta Alpha Psi Professional of the Year Darren Jackson is a 1986 Marquette University Accounting alumnus who currently serves as President and Chief Executive Officer of Advance Auto Parts.

Born in Detroit, Michigan, Darren grew up in Grand Rapids in a family of five — parents, Richard and Connie, who have been married for over 40 years, and brothers, Devon and Derek. He has fond memories of Marquette, starting with his acceptance (which Darren joked was the first of a number of surprises Marquette had in store for him) and he maintains close ties with many of the friends he met while attending the university. The things he remembers best about his Marquette years are the closeness of the faculty and students and the caliber of his classmates. Darren feels the reason for his academic success in college, which he acknowledges surpassed that of high school, is attributable to the way Marquette supports their students. Additionally, he is an avid Marquette basketball fan.

Darren began his career at Peat Marwick, which in 1987 joined forces with Thomson McLintock/ KMG to form KPMG — the first mega-merger of large accounting firms. He then moved to Carson Pirie Scott & Company, where he held various senior positions including Chief Financial Officer. He also worked for Nordstrom, Inc., Full-line Stores, a fashion specialty retailer, serving as Vice President and Chief Financial Officer. In 2000 Darren joined Best Buy Co., Inc., and was appointed Executive Vice President-Finance and Chief Financial Officer in February of 2001. He served in various executive positions with Best Buy, ultimately taking on the job of Executive Vice President of Customer Operating Groups. Darren's current position as President and CEO at Advance Auto Parts, where he has been a board member since July 2004, began in January of 2008.

Darren lives in St. Paul, Minnesota, with his wife Terry, a Marquette University 1987 nursing alumna, and their three children Ryan, Bridget and Danny. Ryan is 19 and will be a sophomore at Marquette next year; Bridget is 16 and a junior at Cretin Derham High School; and Danny, age 11, is in the sixth grade. Outside of work, Darren enjoys biking, reading, and whitewater rafting with his family. He is a director of Cristo Rey Network, a nonprofit organization whose mission is to put Catholic high schools in urban areas, serving the poor and transforming urban America one student at a time. He is active in the Cristo Rey Network both locally and nationally. Darren is on Marquette's Board of Trustees and serves as Vice Chairman of the Board, his favorite nonpaying job. He considers it a privilege to be in a position to give back to a university that gave him so much. Darren hopes to bring relevant business experience to the university setting, as well as constructive debate and insight to help the university grow and prosper while fulfilling its fourfold mission of service, excellence,

In considering the qualities that have helped him succeed, Darren advises current business/ accounting students to be curious, take risks, and to not underestimate their potential. Additionally he suggests "become engaged and give back." Darren believes that Marquette provides not only the technical training students need to be successful but, critically, develops the individual as a whole. For Darren, the emphasis placed on Marquette's mission and the values instilled upon students while attending the university make all the difference.

Brad Kalscheur: Staying Open to Possibilities and Options

Brad Kalscheur was recently elected to partnership in the Wealth Preservation Planning practice group at Michael Best & Friedrich LLP. While becoming a partner in a law firm was a future goal when he left tiny Port Edwards, Wisconsin, to enter Marquette University in the fall of 1985, Brad found that his path and timetable turned out differently than expected.

As editor of his high school newspaper, Brad initially considered journalism as a major. After seeing the starting salaries and the political bent of most journalists, however, Brad turned his attention to law school, with the all-important undergraduate step of obtaining a business major. Brad felt this would provide him with the best foundation for practicing law so he applied to the College of Business Administration at Marquette University. His oldest brother (now a Jesuit and a professor at Boston College) had just finished Georgetown and was starting law school, and his second brother was already at Marquette, so the family was getting quite comfortable with the Jesuits and their tradition of educational excellence. Brad's initial plan was to major in marketing, but after taking his first accounting course in his sophomore year, he decided that the best preparation for the analytical skills required for a career in business law was accounting. There was the additional advantage that if he did not go to law school right away, he would have an employable major after graduation.

As an accounting major with an interest in auditing, Brad planned to start down the audit trail as most interested students did, by interviewing for spring semester internships and accepting one in the auditing field. One of the internships he interviewed for turned

out to be in the tax department at KPMG. After the interviews were completed and preferences ranked, Dr. Frank Probst, who ran the internship program at that time, asked Brad if he would be interested in the tax internship. Prior to that time, Brad had not considered starting directly in tax, but after he looked at the opportunities available in business law to someone with a tax background, he gladly accepted. That decision, which seemed a small one to the 20-year-old college junior, led to a 19-year (and counting) career in tax.

Though he had a job offer from KPMG in hand at the end of the internship, Brad entered his senior year still with thoughts of going to law school immediately after graduation. But upon graduating, he decided instead to join the operating tax department in KPMG's Washington, DC, office, thinking his political science minor might be of some advantage in the nation's capital. During his three years at KPMG, Brad worked primarily in the area of partnership taxation. His KPMG starting class in tax consisted of three lawyers, three masters in tax from the University of Virginia and three "just undergrads." Brad's Midwestern work ethic and Marquette accounting education (he especially credits Dr. Jim Trebby's tax classes) allowed him not just to be intellectually competitive with his start class but also to excel at KPMG.

After finally passing the CPA exam with a "perfect" score of 300 and having worked for long enough for licensure as a CPA, Brad decided it was time to go to law school. In 1992 he came back to Milwaukee and Marquette. Brad knew that once he earned his law degree, he wanted to practice some form of tax law, something perhaps in general business tax. While at Marquette's Law School, he received the Joseph I. Swietlik

Scholarship for highest achievement in tax classes. At the recommendation of Professor Patricia Bradford, who, along with Dr. Trebby, Brad credits with giving him his solid foundation in tax, he started his legal career in 1995 in the estate planning department of Weiss Berzowski Brady LLP. In 2002, Brad went to work for Michael Best. Brad's practice includes all areas of estate and business succession planning. Brad remarked that most people he talks to think the job of an estate planner would be somewhat routine, but "every family dynamic and situation is different, and you're dealing

with mortality, money and sibling rivalry, so my work is far from boring. Plus I'm helping people avoid (not evade) taxes, which as we all learned the first day of intro tax class from Dr. Trebby, tax evasion is illegal, but tax avoidance is perfectly acceptable and should be encouraged."

In 1996, Brad
was asked by the
Marquette University
Business Administration
Alumni Association (MUBAAA)
to speak in the law and graduate

school room at the annual Career
Awareness Night (CAN). For the ensuing 12
years, he has told each class of freshmen at CAN that
they "already made their first right decision about going
to law school by being business majors, and the next one
would to be to decide to be accounting majors."

That first Career Night began Brad's service to MUBAAA, which later involved joining the golf committee, which raises scholarship money for undergrads. In 1999, he formally joined the MUBAAA as a director and served as its President in 2005-2006. He continues to serve as the MUBAAA's representative on the National Alumni Board. Brad actively participates in the mentoring program, serves on the Accounting Advisory Board, and he

attempted to give a voice to the great silent majority of Warrior advocates by serving on the Nickname Advisory Committee in 1995. Outside of Marquette proper, but never far from the Jesuits, Brad also works with the Jesuit Partnership for the Wisconsin Province of the Society of Jesus.

When not working, Brad enjoys attending MU basketball games during the winter and golfing during the summer. One weekend is spent at the "Warrior Open" with Marquette friends made on 7 North of Schroeder Hall as a freshman. He also takes

experiencing many changes in his own career path, both unexpected and positive, Brad always encourages the students he encounters to stay open to possibilities and options.

Brad appreciates the friendships forged at Marquette and

the opportunities that his undergraduate and law degrees from Marquette opened up for him, and he is committed to giving back his time, talent and treasure as much as possible to Marquette. He asks his fellow alumni to think about the gifts they have received and the relationships they have built through Marquette and encourages them to give back of their time and talent (if not their treasure) to the College and to the university. As Brad often says, "even if they can't officially be Marquette Warriors, we all still must be Warriors for Marquette."

Daniel Szidon:

Staying Connected to the Important Things

When Daniel Szidon began his academic career at Marquette University, his aspiration was to work with his dad, part owner of a car dealership. It was his instructor for his first Accounting course, Michael Dole, who pulled Dan aside and said, "If you really want to help your dad and his business, learn accounting." Dan took Mike's advice and has not looked back since.

A 1990 Marquette University Accounting alumnus, Dan is currently an Audit Partner and Head of the Audit/Accounting Service Line at Wipfli LLP. His responsibilities include managing a number of clients in a variety of industries. What he enjoys the most is training and developing young, talented professionals and helping them reach their goals. These young professionals, Dan has noticed, continue to raise the bar for industry performance and are miles ahead of where he and his colleagues were at the same age and experience level. For Dan, watching these young people grow and blossom is a joy. In his work with them, Dan has tried to break the traditional mold of public accounting as a field that "chews them [young professionals] up and spits them out." He wants to ensure that public accounting is looked at as a career and not just a stepping stone.

Dan grew up in Peoria, Illinois, with his parents, older brother, and older sister. He attended a Catholic high school and, subsequently, chose Marquette because receiving a Jesuit education was very important to him. Since every year a number of students from his high school attended Marquette, he knew he would find many familiar faces around campus. In addition, Dan's sister's best friend was a student at Marquette and her guidance helped make his decision even easier. After his first visit to campus and meetings with professors, he had no doubts: "Marquette just felt right."

Dan's favorite memories of Marquette include his professors, his experience with student government, his friends, and, curiously enough, his last summer before graduating. Dan's professors brought real life knowledge to the classroom and enthusiasm for the topics covered

— two essentials, Dan believes, in building a solid accounting foundation. As an active member of the student government. Dan met undergrads he would not normally have come in contact with. He believes this exposure to new people and ideas is exactly what college is all about. While at Marquette, Dan made lifelong friendships. Even though some friends have moved away, Dan still remains in close contact with them. As for his last summer, it was the nicest Milwaukee had seen in a very long time and Dan, while working and taking classes, realized he wanted to remain in the Milwaukee area.

Dan has continued to be active at Marquette, especially with the Accounting Department and the College of Business Administration. He attends many Beta Alpha Psi functions and is a member of the Accounting Advisory Board. Dan lives in Germantown and is married to his high school sweetheart, Michele. In the fall of 2007, the Accounting Department welcomed its newest faculty member, Dr. Qianhua, who goes by "Q," Ling. Q joins Marquette University after graduating from Oklahoma State University with a Ph.D. in accounting.

Q grew up in southern China.Her father teaches art at a vocational college and her mother teaches Chinese at a high school.
