## I. Mission Statement The purpose of the Office of Assessment:

Building on the Mission of the Institution (<a href="http://www.marquette.edu/about/mission.php">http://www.marquette.edu/about/mission.php</a>) and a commitment to student-centered practice, the Office of Assessment at Marquette University supports campus-wide efforts to engage in the meaningful assessment of program- and institutional-level student learning in the search for truth, the discovery and sharing of knowledge, the fostering of personal and professional excellence, the promotion of a life of faith, and the development of leadership expressed in service to others. Specifically, the Office of Assessment at Marquette University will develop, support, and encourage the use of program- and institutional-level student learning assessment strategies that:

#### Excellence

- o Encompass the whole person: spiritual, moral, and intellectual (the heart and mind)
- o Foster and support excellence in teaching and research
- o Are sensitive to a diverse population
- o Offer personal attention and care

#### • Faith

- o Align with the unfettered pursuit of truth
- o Support and value academic freedom
- o Support and value diversity

#### Leadership

- o Align with a liberal arts education
- o Support the development of ethical and informed community leaders
- o Help faculty act as true teacher-scholars and students as true learner-scholars

#### Service

- o Encourage dedication to the service of others
- O Support the struggle for a more just society
