



Exploring the Accounting Major

Businesses, from corner coffee shops to multinational corporations, face tremendous pressures to stay ahead of their competition — and to do it ethically. For solutions they often turn to accountants, who bring a wide range of technical and personal skills.

Preparing for the CPA Exam

Those who wish to engage in public accounting practice in most states as certified public accountants should familiarize themselves with the rules and regulations issued by the various state boards. For example, most states (including Wisconsin and Illinois) require prospective CPAs to complete 150 semester hours of education. The Department of Accounting offers a **master of science in accounting degree** which meets the 150-hour requirement.

One way to reach 150 credit hours could be completing credits at another university. Credits taken at another university after the start of students' final 30 credits do not transfer back to Marquette University, nor do they count towards credit earned towards the 150 hours at Marquette. The current university transfer policy states that all transfer credits must be approved in advance and the last 30 credits must be taken at Marquette University. Students can also pursue summer courses and a ninth semester of their undergraduate degree to hit 150 credit hours. Students are encouraged to work with their academic advisor to plan ahead.

Types of Positions

Students who study Accounting at Marquette generally focus on tax or audit accounting.

Tax Accounting: In this specialty area of accounting, one may be working in public accounting where they review financial statements to assess tax liability for the business.

Audit Accounting: In this specialty area, one can either work in internal or external auditing. As an internal audit accountant, one would work for a company in any industry and audit their procedures to ensure the company is efficient in protecting their assets. As an external auditor, one works for a public accounting firm where they meet with clients and assess their procedures to ensure their financial statements are federally compliant.

To get experience in these areas, generally students start early in their Marquette education by getting internships through programs such as Accounting Early Recruiting. Some internships held by students were:

- Auditing Intern
- Accounting Intern
- Fund Accountant Intern
- Audit/Tax Internship
- Tax Reporting and Advisory Internship
- Accounting and Investment Operations Intern

Students first roles after graduation include titles such as:

- Auditor
- Staff Tax Accountant

- Staff Assurance
- Tax Associate
- Valuation Associate
- General Accountant

Types of Employers

Accountants can work for many different types of organizations depending on their specialization, interests, and goals. One could work at a private organization ensuring the company is being efficient and legal in handling their finances.
