- o If you or your spouse were not required to file a 2022 Federal Income Tax Return with the IRS:
  - Select either B or C under Student and/or Spouse Information on the 2<sup>nd</sup> page of this form.
  - If you or your spouse had income: attach all 2022 W-2s, 1099s, or other income statements.
  - If you or your spouse would have filed a tax return outside of the U.S.: submit a letter from the appropriate tax filing authority that the individuals did not file taxes.
- Requested documents must be submitted within 30 days of the initial request to be considered for all available financial aid.
