



Readmission and Academic Censure/Satisfactory Academic Progress Appeal: Undergraduate

Purpose: used by former students to appeal academic dismissal from a college or the university and/or failure to maintain Satisfactory Academic Progress for financial aid eligibility the last term of attendance and **also wish to seek readmission to the university as an undergraduate.**

Student Instructions

 - a **handwritten form will not be accepted.**
 - an incomplete form without the required documents attached will not be processed and returned to you for completion.
- Print the form using the 'Print Form' button.
- Type answers to the questions in Section 5 in a separate document.
- Sign the form in Section 6; a digital signature is **not** acceptable.
- Submit the signed appeal form, the document in Section 5 and any supporting documentation by the deadline for readmission, as per the [Academic Calendar](#) via one of the methods listed at the bottom of page 2 of this form.
- All appeals and supporting documents must be **received** by the deadline. **No exceptions will be made to the deadline.**

Notes:

- if you have a Bursar or Student Affairs hold that will prevent you from being readmitted, clear these with the appropriate office.
- transcripts are not accepted if delivered by the student; they must be received via mail directly from the high school or postsecondary institution's record office.
- the request will be reviewed by the Academic Censure Committee and colleges in rank order indicated below.
- this is a request for readmission and is not a guarantee of acceptance, or a guarantee of being admitted to your requested major, if readmitted.
- Professional Studies students: the Professional Communication major is in the College of Communication; all other majors are in the College of Arts & Sciences.
