Throughout the Education course sequences, pre-service teachers are taught to effectively integrate technology into curricula and instruction, to collect data, to

manage data and to analyze data to improve teaching and learning. For example, in the course "Introduction to Learning and Assessment," students are taught to use technologies to enhance learning and assessment. This is just one example of how technology continues to be woven and integrated throughout the sequence of Education coursework. In addition, during their semester of student teaching experience, students must demonstrate their ability to adapt instruction based on data collection and analysis. Technology continues to be utilized in that process.

Students in the College of Education must successfully complete the course "Methods of Teaching Children/Youth with Exceptional Needs," which is designed to provide teacher candidates with knowledge of and opportunities to apply research-based differentiated instructional and behavioral management methods and adaptations for students with a variety of special needs. This class provides an introduction to children and youth with a wide range of exceptional educational need: including students with diagnosed disabilities and with limited proficiency in English. In addition to coursework, 20 hours of field experience is required. The course focuses on how to implement universal design strategies, RTI, and PBIS in the regular classroom setting. The readings, class discussions, and assignments prepare students to work collaboratively with colleagues in their school communities, as well as with families.

Consistent with Jesuit tradition, the College of Education programs at Marquette University prepare teachers, school counselors, counseling psychologists, community counselors and administrators to demonstrate a commitment to social justice through their work. This commitment is expressed first through our undergraduate and graduate students becoming excellent professionals who exhibit a deep knowledge and understanding of their disciplines, as well as how children, adolescents, and adults learn and develop. The commitment is further realized as students master the requisite skills of their profession.
