Re: Annual Report of Marquette University Police Department Advisory Board

This report is respectfully submitted pursuant to § 114 of the Advisory Board's Rules, which requires the Board to "report of its activities" at least once per year. 1

In brief, the Board met four times during the 2024-2025 academic year. The minutes of all four meetings are attached to this memorandum. The meetings were informative and constructive. Police Department personnel provided extensive updates on the Department's activities and initiatives, as detailed in the attached minutes. Members of the Board provided feedback and suggestions.

Notable topics covered in our discussions included, among others:

- Success of the Department's Behavioral Health Unit amidst the growing challenges of dealing with mentally ill individuals in the Department's patrol zone
- Departmental hiring
- Departmental preparations and activities in relation to the Republican National Convention
- Community relations initiatives, such as regular Coffee with a Cop events and appearances by the Department's dog, Blue
- Crime trends in the Department's patrol zone, including generally positive trends in 2025
- Disposition of citizen complaints
- The Department's tenth anniversary in May 2025

  - a. Republican National Convention (RNC) 07.15.2024-07.18.2024 (J. Kranz):
    - Despite potential for disruption and violence, protests were largely uneventful due to law enforcement engagement with protesting groups
    - Less than 15 individuals arrested during RNC
    - Vehicle transporting U.S. Secret Service hit by vehicle fleeing two separate area shootings; suspect apprehended; no injuries
    - MUPD squad car struck/totaled by mentally ill individual seeking to fulfill perceived order from God to "take out a cop;" suspect apprehended; no injuries
    - MUPD assisted with crime scene at King Park where armed individual was shot and killed by members of the Columbus (OH) Police Department in defense of unarmed individual
    - MUPD assisted with traffic back-up at RNC Checkpoint at intersection of 9<sup>th</sup> and Wells Streets until logistics rectified
    - Majority of nearly 2,000 federal agents housed on-campus were pleased with accommodations, food, and recreational facilities
  - b. Crime Trends (Peters/Kranz)
    - Summary attached
    - MUPD invited to participate in U.S. Department of Justice (DOJ) pilot audit that
      will eventually be conducted for all Wisconsin law enforcement; purpose of
      audit is to ensure that textual narrative records are accurately reported to DOJ;
      while MUPD did well, certain statistics (e.g., "intimidation" vs. "disorderly

- conduct") require greater refinement
- MUPD upward trend in personal crimes from 2023 to 2024 is not attributable to any one single factor
- MUPD experienced only a 1% annual increase in motor vehicle thefts despite
  Milwaukee Police Department's significant spike (46%); MUPD's success largely
  attributable to increasing patrols at parking structures and the distribution of
  400 "Club" anti-theft devices donated by auto manufacturers
- MUPD has noted trends in east Milwaukee that have not yet moved west, including car thieves arming themselves (which has traditionally not been the case with thieves who are typically 17-22 years of age); and thieves breaking into cars regardless whether valuables are visible in order to search for handguns stored under seats that can't be carried into establishments such as bars and Fiserve Forum

- No homicides.
- 13 robberies in 2024. 38% decrease over 2023.
  - o Since our last meeting, 4 incidents. Two involving students, two non-MU. No injuries.
  - <u>Note</u>: MUPD currently has a 100% clearance rate for 2024 robberies.
- No thefts from person.
- 121 assaults in 2024. 41% increase over 2023, <u>Note</u>: Similar to that experienced by MPD.
  - Since our last meeting, 3 aggravated assault incidents, 4 victims. 1 MUPD officer; two students who were endangered by a reckless auto, no injuries; 1 child abuse.
  - Since our last meeting, 7 simple assault incidents, 9 victims. 4 MUPD officers; all others non-MU (2 domestic violence).
  - Since our last meeting, 11 intimidation incidents, 15 victims (9 students). Most were subjects behaving in a disorderly manner that made the victim(s) fear for their safety. Two were students harassing other students.
  - o *Notes*:
    - Many of the assault perpetrators have unaddressed mental health needs.
    - 2024 increase largely attributable to change in reporting definition of "assault" which now includes "disorderly conduct" if the victim indicates "fear for own safety," even if no unwanted physical harm or contact.
- 7 sexual assaults in 2024. 22% decrease over 2023.
  - Since our last meeting, 2 fondling incidents, 1 student victim.
- 25 burglaries in 2024. 48% decrease over 2023.

- Since our last meeting, 6 incidents, 2 with student victims. Packages in lobbies and coin-op machines were targeted. Also 1 at a construction site and 1 local business.
- 276 thefts in 2024. 9% increase over 2023.
  - Since our last meeting, 17 shoplifting cases, two thefts from a building, 26 thefts from motor vehicles, 12 other larcenies (mostly packages from porches).
- 86 motor vehicle thefts. 14% decrease over 2023.
  - Since our last meeting, 16 incidents. 6 student victims. Mostly Kia/Hyundai. Three Infiniti vehicles, two others with keys/running.
- 3 arson incidents. 200% increase over 2023, when there was only 1 incident. None since our last meeting.
  - <u>Note</u>: Of the 3 arson incidents, 2 were committed by same perpetrator who is in custody.

- 14 Robberies in 2024. 44% annual decrease from 2024.
- 0 Thefts from Person.
- 140 Assaults/Batteries in 2024. 33% annual increase from 2024.
  - o 13 MUPD Officers assaulted/battered
  - o Many of the assaults/battery perpetrators have unaddressed mental health needs
  - Increase seems to correlate with opening of Mental Health Emergency Center at 1525
     N. 12th Street
- 9 Sexual Assault/Rapes in 2024. Same as 2023.
- 27 Burglaries in 2024. 49% annual decrease from 2023.
- 319 Thefts in 2024. 3% annual increase from 2023.
- 97 Motor Vehicle thefts. 31% annual decrease from 2023.
  - o Largely attributable to effectiveness of The Club anti-theft device
- 3 Arson incidents. 300% increase over 2023, when there was only 1 incident.
  - o Of the 3 arson incidents, 2 were committed by same perpetrator

b. <u>Near West Side Safety Issues</u> (Krantz): Violence and gun-related crimes are escalating, largely due to transient housing which is poorly managed, spilling over into Marquette campus, which is a challenge for MUPD because Sherriff will not jail suspects accused of violent misdemeanors (other than domestic violence) due to capacity issues.

#### Examples:

- January 29, 2025, incident involving male suspect aiming rifle out car window at pedestrian mother and daughter. MUPD was forced to book and release misdemeanor suspect (after confiscating rifle).
- January 31, 2025, incident involving male burglary suspect arrested at Alumni Memorial Union but booked and released despite 20 previous MUPD contacts (history of mental health issue). Suspect subsequently burned himself and his apartment in an attempt to disperse evil spirits.

- e. <u>Personnel Issues</u>: (Kranz)

Officer Isaiah Espino charged by Milwaukee County District Attorney with Felony I Misconduct in Public Office in violation of Wis. Stat. § 946.12(3) due to testimony he delivered at a trial on November 11, 2024, in Milwaukee Municipal Court during which he

admitted to intentionally attempting to botch his Incident Report in order to assist the defendant whom he had arrested for OWI on April 10, 2023. Officer Espino has pled not guilty alleging that, as an MUPD officer, he is not a "public official" under Wis. Stat. § 946.12(3).

- i. Incident Report was eventually corrected due to managerial oversight according to Milwaukee Police Department's independent investigation.
- ii. Officer Espino is currently on unpaid administrative leave while MUPD investigates.
- iii. Any open MUPD citations issued by Officer Espino will not be prosecuted because prosecutors will not call him as a witness (i.e., "Brady List").

#### f. <u>Citizen Complaints</u>: (Hudson)

- Mother of female undergraduate complained of excessive force regarding brief handcuffing of her daughter in January 2025 on suspicion of shoplifting (released after exonerated).
  - MUPD Officer acted within his discretion (requires balancing various factors including probable cause; suspect cooperation; safety of officer and community).
  - MUPD policy is to treat suspects (both MU-related suspects and community suspects) equally.
  - Nevertheless, via peer-to-peer counseling, arresting officer recognized that incident could/should have been avoided.
  - Mother's concerns resolved.

- Aggravated Assaults were at 10 for 2025, compared to 10 for 2024.
- Simple Assaults were at 10 for 2025, compared to 15 for 2024.
- Intimidations were at 16 for 2025, compared to 3 for 2024 (spike due to reclassifying "disorderly conduct" under certain circumstances as "intimidation," a form of assault).
- Of 12 Burglaries in 2025, 6 were same location; 5 involved same perpetrator.
- Thefts did not involve students.

#### b. Near West Side Safety Issues (Kranz):

- i. Violent crime is area surrounding Marquette seeing uptick in violence (e.g., shooting at laundromat)
  - Calls for service in 2025 are up 45%
  - Total minutes per call for 2025 is down 13%
  - Behavior health calls in 2025 are down 47%
- ii. Car thefts, particularly KIAs and Hyundais, are up in 2025, including through use of blank key fobs and breaking door handles (same 11-year-old perpetrator arrested twice).

# c. <u>Departmental Activities</u>: (Peterson; Hensley; Hudson)

- i. Kickball at Bruce-Guadalupe Community School (3-5<sup>th</sup> graders) MUPD and Milwaukee Police Department (twice weekly April-June 2025)
- ii. "Blue" Activities:
  - Coffee with a Cop: 2-3 per month at the Law School; Dental School; Business School; and Alumni Memorial Union.
  - Pre-Exam De-Stressing Appearances (5-15 minutes) by student request at classrooms preapproved by instructor.
  - Marquette's Admitted Student Day (April 5 & 12, 2025) appearances with prospective students.
- iii. National Alliance Mental Illness (NAMI) Wisconsin is hosting a CIT (Crisis Intervention Team) Symposium at the Sheraton Milwaukee Brookfield Hotel from May 20-22, 2025. This symposium is a no-cost event that focuses on mental health and responding to the aging population and those living with dementia.
  - MUPD to present Crisis Intervention Team training regarding:
    - Homelessness
    - o Mental Health
