

INSTRUCTIONS FOR PROVIDING A STATEMENT OF FINANCIAL SPONSORSHIP

TO THE STUDENT:

If you plan to enroll at Marquette University with F-1 (student) or with J-1 (exchange visitor) visa status based on Marquette legal documents, we are required by law to verify your financial ability to meet your expenses. That verification includes one or more official statements of financial support. Please see the following instructions and provide your sponsorship statement(s) to your admitting office at the College of Health Sciences.

If all of your financial support will come from **one private sponsor**, please complete the information below and then ask your sponsor to read and complete page two of this form.

If all or part of your financial support will be from your **own personal funds**, please send us a current, official bank statement or similar account evidence that proves the availability of the total amount of money for the full duration of your studies.

If your financial support will come from your **government**, please arrange for your government to send us its official sponsorship document for you to study at Marquette University.

If you will have **more than one sponsor**, please make a copy of this form (both sides) for each sponsor, complete the information below for each form, and ask each sponsor to read and complete page two of the respective form.

TO THE SPONSOR:

We have been informed that you will provide financial support for the student named above. Please read the following information about finances.

The U.S. government places regulations upon both the F-1 or J-1 visa student and the student's university. Because of these regulations, Marquette University requires a Statement of Financial Sponsorship (such as the form on the other side of this paper) and an advance deposit of money.

The Statement of Financial Sponsorship which we now need from you has two parts. Part I is your detailed guarantee of financial sponsorship for the student's living and studies at Marquette University. Part II is an official's attestation that you are truly the person who has signed Part I. You can use the form on page two of this form, or you can write your own statement to indicate all of the same assurances regarding your financial support for this student. This statement is for Marquette purposes. The United States government may require a different financial statement.

The official Marquette University cost estimate for tuition in the professional phase of the Doctor of Physical Therapy Program is \$36,840 and basic living and incidental expenses for F-1 and J-1 visa students during the 2013-2014 year is U.S. \$14,300. In practice, some students spend more money while others spend slightly less. The total estimated cost for the program for 2013-2014 is **\$51,140**. Costs are expected to increase each year.
